Lucy Gans, earned her MFA from Pratt Institute, Brooklyn, NY, in sculpture with Calvin Albert and Robert Zakarian with a minor in drawing with George McNeil. She also studied painting and drawing at the Art Students League, New York, NY, with Bruce Dorfman. She earned her BFA from Lake Erie College, Painesville, OH. She has taught in schools, colleges and universities in Ohio, New York, Alabama and Pennsylvania for over 35 years.

Gans is the first holder of the Louis & Jane Weinstock '36 Chair of Art and Architecture at Lehigh University. She teaches sculpture and drawing and is also an affiliated faculty member in the Women Gender and Sexuality Studies Program. In addition, she is an artist/teacher in the Vermont College MFA program.

Her work is figurative, narrative and socially situated and ranges from individually carved figures to installations with cast objects, prints and narrative text. Her exhibition, "In Our Own Words," at Zoellner Center for the Arts' Gallery, Lehigh University, was composed of over 400 ceramic heads, eight looping audio tracks and accompanying text. The subject was Domestic Violence and the audio component was culled from interviews with survivors; the exhibition received a special award from the Fine Arts Commission for Social Impact. Her work is in many public and private collections in this country and abroad and she has been the recipient of the National Association of Women Artists, Medal of Honor, the Peabody award for her work in printmaking and the Clara Shainless Memorial Award.

## ELIGIBILITY

All artists must be 18 years or older.

Maximum of three works may be submitted; up to three works may be accepted.

Each entry must be an original design concept of the artist, executed within the last three years. Work done in a workshop or with an instructor is ineligible. Committee reserves the right to decline any work that suggests copyright infringement.

Work previously **exhibited** in a BAA juried show will not be accepted. Previously **declined** works may be reentered. If work that has been exhibited in a previous BAA juried show is reentered, the artist will be prohibited from entering any artwork the following year.

All 2D and 3D media are eligible, with the few exceptions noted here.

All work must be original; mechanical reproductions are not eligible, including reproductions that have been enhanced by the artist.

Hand-pulled prints (or professional-quality prints in the case of digital art) must be clearly labeled as such.

No video or installations.

## ENTRY PROCEDURE

### DIGITAL ENTRY PREPARATIONS

- Digital entries must be JPG format with a resolution of 300 dpi.
- Image size should be between 1500 pixels (5") and 1950 pixels (6.5" ) on the longest dimension.
- Naming files: LastName\_FirstName\_A(or B or C)\_title  
(example: doe\_john\_A\_RedRobin)
- Show only the image; no frame, mat or background.
- **REMEMBER:** your art will be judged from the photograph you submit; make it as professional as you can.
- Go to [www.berksartalliance.com](http://www.berksartalliance.com) to enter.

### FEES

BAA members pay \$15 first item, \$10 each for second and third items; non-members pay \$25 for first item, \$15 each for second and third items.

If you wish to become a member or renew your membership, go to the website, then the membership page, and download the membership application.

Submissions accepted March 21-June 26.

## PRESENTATION

All 2D works must be ready to hang and securely wired. Clip frames are not acceptable. All works on paper, matted or not, or in shadow boxes, must be protected with a covering of glass or plastic.

Neither the Berks Art Alliance nor GoggleWorks Center for the Arts will be responsible for any glass or plexiglass breakage.

All works must be completely dry.

Maximum size for hanging work is 60" in any direction, including frame. All multi-part 2D works must be within one frame, or parts securely attached to each other.

Sculpture must not exceed 60 pounds, and must safely fit on a 24" square pedestal, or on the floor. Inquire in writing before submitting work requiring unusual floor space.

Intake committee reserves the right to exclude any piece that is not suitably framed and wired for hanging, or that would be considered hazardous in a public place, or that differs significantly from the digital image submitted.

## INSURANCE/SALES

Insurance is limited to the duration of the show. Insurance claims must be made to GoggleWorks Center for the Arts prior to the removal of art from the exhibition space. No other claims will be honored.

All artwork must be for sale. A 35% commission on all sales will be charged. Artwork selected for the Patrons' Choices\* will become the property of the patron after full price is paid. All sales are final.

\*A patron supports the juried show by pledging \$200 in advance in order to have the opportunity to choose an accepted piece prior to the show opening.

Submission to this exhibit grants permission for photography of your work for promotional and educational purposes connected with the exhibition.
